Vaccination Policy

As per ONN's policy, all in person events or meetings (on-site or off-site) that ONN hosts and manages directly require full vaccination against COVID-19. Proof of vaccination may be required. ONN encourages all attendees to take rapid tests prior to attending and stay home if they are experiencing any symptoms.

Masking may be required throughout MTCC pending current public health guidelines. MTCC updated their HVAC systems during the COVID-19 pandemic in order to improve ventilation. The MTCC has above standard ventilation and air exchange systems in place including MERV filtration.

ONN will monitor public health guidelines in the lead up to the event and communicate any changes to the event and/or vaccination policy to attendees prior to the conference.

Conference attendees will receive email confirmation after completing their online registration; a payment receipt will be sent by email only following full completed payment. Only those attendees who have completed registration, and have paid in full will be able to attend the conference, unless previous financial arrangements have been made with ONN.
